# **Financial Resources**

#### 3/30/20 Federal Assistance

The <u>Families First Coronavirus Response Act</u> authorizes a variety of programs related to the coronavirus such as paid sick leave, expanded unemployment benefits, free virus testing, nutrition benefits and other programs. The <u>Coronavirus Aid, Relief, and Economic Security (CARES) Act</u> aims to help small businesses, the self-employed, employees and others who are struggling financially. More information is detailed throughout this document.

# 3/30/20 CARES Act Cash Payments

Tax filers earning less can \$75,000 will receive a one-time cash payment of \$1,200 and an additional \$500 per child. Those earning over \$75,000 and up to \$99,000 will receive a phased down payment. In order to receive this payment, the individual or couple must have filed taxes in 2018 or 2019 (except those that receive Social Security). The deadline to file 2019 income tax forms has been extended to July 15, 2020. IRS Cornonavirus website

#### 4/6/20 Unemployment Insurance for Workers and Parents

The California Employment Development Department (EDD) is issuing additional unemployment benefits. Workers who are temporarily unemployed or have reduced hours due to COVID-19 can apply for unemployment. Parents who have to miss work to care for their children because of school closures can apply for unemployment. The 1-week unpaid waiting period has been waived. Benefit amounts have been increased by \$600 per week and the benefit period has been extended by 13 weeks.

# 4/6/20 Paid Family Leave & Disability Insurance

The California Employment Development Department (EDD) provides Disability Insurance to workers who are unable to work because they have been exposed to COVID-19 or are sick with the virus. The EDD provides Paid Family Leave to workers who are unable to work because they are caring for an ill or quarantined family member. <u>EDD COVID-19 Resources</u>

#### 4/6/20 Relief for Small Businesses

The Small Business Administration (SBA) can provide low interest loans to small businesses. The CARES Act has authorized the SBA to provide additional resources to small businesses impacted. They are now providing a <a href="Paycheck Protection Program">Paycheck Protection Program</a>, <a href="EIDL Loan Advance">EIDL Loan Advance</a>, <a href="SBA">SBA</a></a>
<a href="Express Bridge Loans">Express Bridge Loans</a>, and <a href="SBA Debt Relief">SBA Debt Relief</a>. Many of these new programs are not traditional loans, and the debt may not have to be paid back.

# 4/13/20 Pandemic Unemployment for Self-Employed Workers

The CARES Act creates an unemployment benefit for those that don't qualify for traditional unemployment benefits (like the self-employed), called Pandemic Unemployment Assistance (PUA). The application will be available through California's Employment Development Department (EDD) soon. The EDD is working with state partners to set up this new program. #### 4/6/20 Paid Sick Leave

Employees can take accrued paid sick leave if they are experiencing COVID-19 symptoms and seeking medical advice, quarantined, or caring for a child because school is closed due to COVID-19.

#### 3/24/20 CalWORKs and Cash Aid

#### 4/6/20 Pandemic EBT for Students

Pandemic EBT benefits will be issued to families with school-age children who qualify for free or reduced price school meals. Pandemic EBT will be issued on a new EBT card, separate from any other EBT card the family may have. Children do not need to be CalFresh eligible to receive Pandemic EBT. This program will provide funds for families to purchase food. Cards will be sent to families soon. Pandemic EBT Fact Sheet

#### 4/6/20 School Meals

Schools are continuing to provide meals to all children. Meals are not available during spring break, but families were given the opportunity to receive a weeks worth of meals before spring break. Schools meals will continue to be available after spring break. Check your school district website for more information.

# 4/13/20 Health Care Coverage for COVID-19

Treatment for emergency medical care related to COVID-19 will be covered by Medi-Cal, whether you are in the program, uninsured, or the treatment is not covered by your health insurance. The Medi-Cal program will cover this necessary care.

#### 4/13/20 Medi-Cal & Covered California Health Insurance

Medi-Cal provides full-scope health insurance to low-income Californians. Covered California provides full-scope health insurance at a sliding scale to Californians. Medi-Cal is open for enrollment all year round. Covered California has extended their open enrollment period through the end of June! # 3/24/20 CalWORKs Housing Programs
